Algimantas Čepas is the director of Vilnius Institute for Advanced Studies and an associate professor at the Department of Criminology (Faculty of Philosophy) of Vilnius University. A.Čepas also holds the position of director of the Center for Crime Prevention in Lithuania. He has acquired his PhD in law from Vilnius University in 2002 and has held a number of important positions both in academia and legal institutions: the director of the Law Institute of Lithuania by the Ministry of Justice of the Republic of Lithuania, an advisor to the Minister of Justice of the Republic of Lithuania, an advisor to the Committee of Law and Order of the Parliament of the Republic of Lithuania, the chairman of the "Transparency International" Lithuanian Chapter, a member of the Working Group for the final drafting of the Criminal Code of the Republic of Lithuania, the president of the Lithuanian Association of Criminology, etc. A.Čepas has headed several research and advocacy projects funded by the Research Council of Lithuania, EU JUSTICE and EU REC, and others, has published extensively on criminology and human rights.

#### Supporting victims of crime by using a specially trained dog



In 1998, he quit his career as physiotherapist and started working full-time for Hachiko vzw where he became an assistance dog trainer. From then onwards, he became responsible for fundraising, aftercare and facility dogs. In 2016, he became Executive Director of Hachiko vzw. During the spring in 2020, Mark left Hachiko vzw and started working for Canisha vzw, where he is currently responsible for the daily affairs. Other than this, Mark van Gelder fulfils several tasks within the Assistance Dogs world, such as President of the Belgian Assistance Dog Federation (BADF) (since 2013), ADEu board member (since 2013), ADEu liaison with the European Guide Dog Federation (EGDF) (since 2013), appointed by the Flemish Minister of Health as a member of the controlling body which has to certify assistance dog schools since 2014, started working within CEN/TC 452 Assistance Dogs on a European







Standard in 2016, ADI board member since 2020, and he is actively involved in the FYDO project, supervised by VSE with the involvement of other EU partners (since 2021).
